or subscribed doe by these presents make constitute and or-  
daine and appoint our Trusty and loving friends John  
Tompson John Turner seni<sup>r</sup>. Edward Gray and Benjaminine  
Bartlett Jaynly and severally to be our true and lawfull  
attorneys and Attorneys and assigne or assignes for vs and  
in our names and to our proper use to aske demand and  
Receive of and from all and all maner of pson wha-  
ever all such sume and sumes of Manyes goods or what-  
sover is due owing or belonging unto vs for and concerning  
a tract or tracts of Lands Graunted by the honored Court  
of this jurisdiction unto vs which was Purchased of the  
Indian Sachem Josias Wampatucke by Captaine Thomas  
Southeworth; as alsoe one Tract or tracts of Land granted  
vnto vs by the said Court lying and being neare Namassa  
Kepett ponds which was Purchased from the aforesaid Indian  
Sachem by Major Josias Winslow giving and by these presents  
Graunting vnto our said Attorney or attorneys assigne or ad-  
signes our full power and authoritie Concerning the said  
lands Purchased by Major Josias Winslow and Captaine  
Thomas Southeworth; to prosecute according to Law what  
they haue alredy begun or by arbitration to make a finall  
end or Iſſue concerning any damage or molestation that  
hath binne done to or upon the aforesaid Lands by any pson  
whatsoever and further to arrest Implead Condemne and  
Imprison all and every such pson or psons that shall molest  
doe any damage to or owe any thinge for the said lands  
and att their wills and pleasures out of Prison againe

to deliver and upon the Receipt of any sum or sums of  
 money or goods whatsoever; discharges and sufficient ac-  
 quittances for us and in our names to make seal and deliver,  
 and one or more Attorney or Attorneys under him or them  
 to make and ordaine; and him and them att his or their will  
 or pleasure to Revanke or make void holding feirme and  
 stable whatsoever our said Attorney or Attorneys shall acte  
 or doe or cause to be legally acted or don in or about the aforesaid  
 lands or p'mises; and to defend all Complaints that are or shall be  
 made concerning the said lands or aforesaid p'mises; In  
 witness whereof wee whose Names are subscribed  
 have sett to our hands and this our seal; this twenty  
 fourth day of May one thousand six hundred sixty  
 and Nine
